**01. E-TENDERS FOR COLLECTION OF VEHICLE ENTRY TAX  
FROM THE COMMERCIAL VEHICLES PASSING

To consider e-tenders received in this office in response to the advertisement published in Daily Sakal, Daily Lokmat, Daily Indian

Express and Daily Samachar vide letter No.ANR/RB/V.E.T./2017-18 dated 10-11-2017.

In response to the advertisement total 05 e-tenders were received office on 04-12-2017 upto 05.00 p.m. Out of the 05 tenders, the earnest money deposit was received by this office from only 04 tenderers, hence 01 tenderer M/s A. C. Kothari, Ahmednagar was not accepted for technical bid evaluation and his tender was rejected due to non submission of earnest money.

The technical bid evaluation for the remaining four tenderers was done and after evaluation one tenderer M/s Kolan Pratap Reddy was rejected as he has not submitted the required valid documents as per terms and conditions of tender notice.

The financial bid of the remaining three tenderers were opened and the comparative statement is mentioned as under :-

The highest rate has been offered by M/s Khalatkar Constructions, Nagpur @ Rs.2,80,19,955-00 for one year. The last years contract bid amount was Rs. 2,20,46,000-00 for the period from 17-12-2016 to 16-12-2017 and the existing contract is going to expire on 16-12-2017.
